MEMORANDUM OF UNDERSTANDING
ON PLACEMENT AND CO-OPERATION

This MOU, based on general discussions & Arguments, is executed on 04 March 2022.

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE"), through its principal Dr. Abhilasha Gautam at having its campus at M-1, Pocket P-5, Greater NOIDA, UP, INDIA.

AND

PRAGYAN PUBLIC SCHOOL, Jewar, UP (hereinafter referred to as "PPS"), through its Principal Ms Deepti Sharma at having its campus at Rampur Rd, Jewar, Uttar Pradesh 203135

The Expressions "AIE" and "PPS" Shall mean and include their respective successions, legal representations and assignees.

1. PURPOSE

The purpose of this MOU is to foster collaboration between AIE & PPS. The aim is to establish a placement and academic link between the two institutions for mutual benefits and in a spirit of friendship and co-operation.

2. OBJECTIVES

The objectives of the MOU are-

- (a) To promote and enhances academic interest between AIE. & PPS.
- (b) To provide placement opportunities at PPS for AIE students.
- (c) To promote research activities between the two institutions.
- (d) To promote student participation between the two institutions.

AIE and PPS are collaborating in order to provide placement opportunities to students enrolled at AIE.

Both parties hereto agree as follows:

1. Decisions regarding the placement of students (such as number of students, dates of placement, frequency of visit, duration, timings etc.) will be taken mutually.
2. PPS shall provide sufficient oversight of the program to ensure that it meets the needs of the students. AIE students will get exposure of working under the PPS School.
3. An orientation will be given to trainees by PPS before placement in classrooms.
4. During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by the PPS team (such as Taking classes, prepare necessary teaching learning material, provide group or individual attention to persons with special needs at PPS, volunteer in events and functions).
5. The minimum salary will be offer for mother teacher- 20,000 plus accommodation, for PRT- 22,000 plus accommodation, for TGT- 25,000 plus accommodation and for PGT- 28,000 plus accommodation.
6. PPS will provide proper appointment letter and experience certification upon successful completion for their service tenure.
7. Army Institute of Education, Greater NOIDA will allow its students to attend the various events/ Seminar/ placement sessions conducted by PPS.
8. This agreement shall be effective for a period of three years from 04 March 2022 to 03 March 2025 Renewal of this agreement and continuation of the Program will be subject to each Party signing a renewal agreement.
9. There will be no financial liability on part of either party.
10. This agreement may be modified at any time by written consent of both Parties and may be terminated by either party at any time by giving at least thirty days' written notice.



The occurrence of such dispute, either Party may, by written notice to other Party, have such dispute referred jointly to the authorized representatives of the Parties, or their successors or counterparts, for an amicable resolution by good faith negotiations within 15 days after such notice is received in respect of such dispute.
