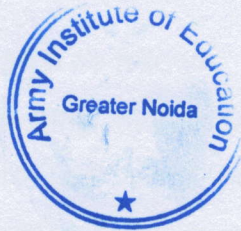

MEMORANDUM OF UNDERSTANDING ON ACADEMIC EXCHANGE AND CO-OPERATION

This MoU is signed and executed on this 04th of August 2021 at Greater NOIDA

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE") having its campus at M-1, Pocket P-5, Sector CHI-2, Greater NOIDA, UP- 201310

AND

SAMSARA-THE WORLD ACADEMY having its location at H.S 21, Sector 37 (RHO-II), 1st Avenue, Semia Estate, Greater NOIDA, UP – 201308.

The Expressions "AIE" and "Samsara-The World Academy" shall mean and include their respective successions, legal representations and assignees.

AIE and SAMSARA-THE WORLD ACADEMY are collaborating for academic association enabling students enrolled in B.Ed. & B.Ed. Special Education (Learning Disability) programme at AIE to observe, intern and implement inclusive teaching practices at SAMSARA-THE WORLD ACADEMY for children with and without special needs. The present MoU will foster collaboration between AIE Greater NOIDA and Samsara-The World Academy Greater NOIDA for education, research and training.

Both parties herein agree as follows:

1. Decisions regarding the engagement of AIE student-teachers for observation and internship at Samsara-The World Academy (such as number of students, dates of school placement, frequency of visit, duration, timings etc.) will be taken mutually.
2. Samsara-The World Academy shall provide sufficient oversight of the inclusive programme to ensure that the AIE interns meet the needs of the students with and without special needs. AIE students will get exposure of working in an inclusive school set up, get an insight into working of an inclusive school and develop requisite knowledge and experience of working in a multi-disciplinary setting.
3. An orientation will be given to AIE interns by Samsara-The World Academy before placement in classrooms for observation and internship with students with and without special needs.



4. During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by Samsara-The World Academy (such as prepare necessary teaching learning material, provide group or individual attention to learners with special needs and learning disability at Samsara-The World Academy, volunteer in events and functions).
5. AIE students will write reports and prepare Individualized Education Programme (IEP), case studies as per the curriculum needs of the teacher education & special education programme of AIE mandated by the affiliating University. A copy of the reports and case studies will be shared with Samsara-The World Academy, if desired.
6. In order to respect the privacy and confidentiality, contact details of the families will not be shared. If required meeting with parents will be arranged by Samsara-The World Academy at their school premises.
7. Samsara-The World Academy will provide with appropriate certification upon successful completion of school observation, engagement and internship.
8. There will be no financial liability on part of either party.
9. This agreement shall be effective for a period of three years ⁰⁴ August 2021 to ⁰³ August 2024. Renewal of this agreement and continuation of the Program will be subject to each Party signing a renewal agreement.
10. This agreement may be modified at any time by written consent of both Parties and may be terminated by either parties at any time by giving at least thirty days written notice.
