

# MEMORANDUM OF UNDERSTANDING

This MoU is signed and executed at NOIDA on this  
Seventh day of January 2019

between

Party 1: **Mata Bhagwanti Chadha Niketan (hereinafter referred to as MBCN)**  
MBCN, A-12, Sector 132, Expressway, Noida, U.P.

And

Party 2: **Army Institute of Education (hereinafter referred to as AIE)**  
Plot M-1, Pocket P-5, Greater NOIDA, Distt- G.B Nagar, Uttar Pradesh, India.

MBCN and AIE are collaborating in order to provide placement opportunities to observe, intern and implement teaching practice to students enrolled at AIE with the objective of an opportunity to experience and gain knowledge and information.

Both parties hereto agree as follows:

1. Decisions regarding the placement of students (such as number of students, dates of placement, frequency of visit, duration, timings etc.) will be taken mutually.
2. MBCN shall provide sufficient oversight of the program to ensure that it meets the needs of the students. AIE students will get exposure of working with people with special needs, get an insight into working of an organization for people with special needs and develop requisite knowledge and experience of working in a multi-disciplinary setting.
3. An orientation will be given to trainees by MBCN before placement in classrooms.
4. During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by the MBCN team (such as prepare necessary teaching learning material, provide group or individual attention to persons with special needs at MBCN, volunteer in events and functions).
5. AIE students will write reports and prepare case studies as mandated by AIE team. A copy of the case study will be shared with AIE/MBCN.
6. In order to respect the privacy and confidentiality, contact details of the families will not be shared. If required meeting with parents will be arranged at MBCN school premises.
7. MBCN will provide with appropriate certification upon successful completion.
8. There will be no financial liability on part of either party.

9. This agreement shall be effective for a period of three years 07 January 2019 to 06 January 2022. Renewal of this agreement and continuation of the Program will be subject to each Party signing a renewal agreement.
10. This agreement may be modified at any time by written consent of both Parties and may be terminated by either parties at any time by giving at least thirty days written notice.
