ANNEXURE - I - INSTRUCTIONS TO TENDERERS

GENERAL

1. Army Institute of Education, Greater Noida invites Tender through two bid system (i.e., Technical and Financial bid) from eligible applicants who fulfill qualification criteria as stipulated in **Annexure VI**. - 3. A tenderer shall submit only one bid in the particular tendering process. A tenderer who Submits or participates in more than one bid, will cause all of the proposals in which the tenderer has participated, to be disqualified. No tenderer can be a sub-contractor while submitting a bid individually in the same bidding process. If the tenderer does not meet the criteria stated above, the tender shall be considered ineligible for participation in tender process and they shall be considered ineligible applicants.

- 5. - 7. All the documents attached with the technical bid should be properly tagged, numbered, signed and stamped by the competent authority.
- 8. The AIE will not responsible for any loss of property, manpower, and issues related to labour and/or labour laws of the bidder, involved in at AIE.
- 9. Bidder will strictly follow all the safety measures as per the rules of the government.
- 10. The agencies will adhere to all safety measures, while going for repair & Replacement.
- 11. Counter conditions by the Tenderer in matters concerning payment of bills shall not be acceptable.
- 12. AIE reserves the right to accept or reject any/all tenders without assigning any reason.

- 14. ARBITRATION CLAUSE. That in case of any dispute between first party (AIE) and the other party (Bidder) arising out of or in relation to the agreement, the dispute shall be referred to Hon'ble Dean for arbitration. The award of the said Arbitrator shall be binding upon both parties. The seat of the arbitration shall be at Army Institute of Education, Greater Noida

15. RIGHT OF ACCEPTANCE OF OFFER

- (a) The AIE reserves the right to accept partly or reject any offer without assigning any reason thereof. The AIE does not pledge itself to accept the lowest or any other tender and reserves to itself the right of acceptance of the whole or any part of the tender or portion of the qty. Bidder shall supply the same at the rate quantity offered.
- (b) In respect of enquiries, which call for procurement of more than one item, the AIE reserves the right to consider and accept the offer for any of the items in the enquiry reserving the right to utilize the offer for balance items at a later stage within the validity of offer.

16. **FORCE MAJEURE**

(a) Should any force majeure circumstances arise, each of the contracting party shall be excused for the non-fulfilment or for the delayed fulfilment of any of its contractual obligations, if the affected party within 14 days of its occurrence informs in a written form the other party.

- (b) Force majeure shall mean fires, floods, natural disasters or other acts such as war, turmoil, strikes, sabotage, explosions and quarantine restriction beyond the control of either party.
- 17. MODIFICATION AND WITHDRAWAL OF BIDS. Bidder can modify his bid any number of times before bid submission closing date and time. Bidder can also withdraw his bid before bid submission closing date and time. Withdrawn is allowed only once in a tender. If a bidder withdraws his bid, he cannot participate in the particular tender again.
- 18. **TERMINATION FOR DEFAULT**. The AIE may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the bidder, terminate this contract in whole or in part in case of the under mentioned reasons: -
 - (a) If the bidder fails to deliver any or all the services within the time period(s) specified it the contract, or any extension thereof granted by the AIE.
 - (b) If the bidder fails to perform any other obligations under the contract.
 - (c) In the event the AIE terminates the contract in whole or in part pursuant to above para, the AIE may hire the bidder at the risk and cost of working bidder under contract as AIE deems appropriate. However, the bidder shall continue the performance of the contract to the extent not terminated.

30 MISCELLANEOUS

In respect of **Two-Bid** system, the TECHNICAL BIDS forwarded by the Bidders will be evaluated by the Customer with reference to the technical criteria and terms & conditions as mentioned in the RFP. The compliance of Technical Bids would be determined on the basis of the parameters specified in the RFP. **The COMMERCIAL BIDS of only those Bidders will be opened whose Technical Bids would clear the Qualification and Technical evaluation**.
 - (a) The Lowest Bid will be decided upon the lowest price quoted by the particular Bidder as per the **Commercial-Bid.** All columns of the Commercial Bids shall be filled in by the bidder. In the event no rate has been quoted for any item(s), leaving space blank will be presumed that the contractor has included the cost of this / these item(s) in other items and rate for such item(s) shall be considered as zero and work will be

required to be executed accordingly. All taxes and duties (including those for which exemption certificates are issued) quoted by the Bidders will be considered. The ultimate cost to the Customer would be the deciding factor for ranking of Bids.

- (b) No document is required to be attached with the commercial bid. Unreasonably inflated or deflated bids may be avoided. Cutting/alteration made in the tender shall render it invalid. The Principal, Army Institute of Education, Greater Noida . reserves the absolute right to reject the tender without assigning reason whatsoever it may be.
