MEMORANDUM OF UNDERSTANDING ON ACADEMIC EXCHANGE AND CO-OPERATION

This MoU is signed and executed on this SEVENTH day of August 2021 at Greater NOIDA

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE") having its campus at M-1, Pocket P-5, Sector CHI-2, Greater NOIDA, UP- 201310

AND

BHAVYA REHABILITATION CLINIC (hereinafter referred as "BRC") having its location at K-36, Panchsheel Garden, Naveen Shahdra, Delhi-110032.

The Expressions "AIE" and "BRC" shall mean and include their respective successions, legal representations and assignees.

AIE and BRC are collaborating for academic association enabling students enrolled in B.Ed. & B.Ed. Special Education (Learning Disability) programme at AIE to observe, intern and implement inclusive teaching practices at BRC for children with special needs. The present MoU will foster Academic Exchange & Cooperation between AIE and BRC in providing Education, Research and Training in the areas of Special Education, Inclusive Education, Cognitive Skills, Early Intervention, Therapy and Psychological Services.

Both parties herein agree as follows:

- Decisions regarding the engagement of AIE student-teachers for observation and internship at BRC (such as number of students, dates of school placement, frequency of visit, duration, timings etc.) will be taken mutually.
- 2. BRC shall provide sufficient oversight of the inclusive and special education programmes to ensure that the AIE interns meet the needs of the students with special needs. AIE students will get exposure of observing, interning and securing placements at BRC.
- 3. An orientation will be given to AIE interns by BRC before placement in learning environment of children with special needs.

4. A coordinator from both AIE and BRC should be appointed to fulfil all the needful tasks

- During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by BRC (such as prepare necessary teaching learning material, provide group or individual attention to learners with special needs at BRC, volunteer in events and functions and undertake research activities).
- AIE students will write reports and prepare Individualised Education Programme (IEP), 6. case studies as per the curriculum needs of special education programme of AIE mandated by the affiliating University. A copy of the reports and case studies will be shared with BRC, if desired.
- In order to respect the privacy and confidentiality, contact details of the families will not be 7. shared. If required meeting with parents will be arranged by BRC at their clinic premises.
- BRC will provide with appropriate certification upon successful completion of observation, 8. engagement and internship to AIE students.
- 9. Any collaboration of AIE & BRC for workshops, training programmes and short term courses etc (online / offline) would be payable, all-inclusive.
- This agreement shall be effective for a period of three years 07 August 2021 to 06 August 10. 2024. Renewal of this agreement and continuation of the Programme will be subject to each Party signing a renewal agreement.
- This agreement may be modified at any time by written consent of both Parties and may 11. be terminated by either parties at any time by giving at least thirty days' written notice.
