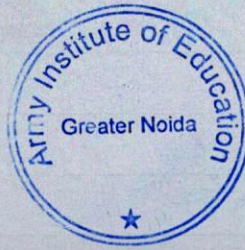

MEMORANDUM OF UNDERSTANDING ON PLACEMENT AND CO-OPERATION

This MOU, based on general discussions & Arguments, is executed on 15 February 2022.

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE"), through its principal Dr. Abhilasha Gautam at having its campus at M-1, Pocket P-5, Greater NOIDA, UP, INDIA

AND

Christ International School, Ahmedpur, Dist- Latur, Maharashtra (hereinafter referred to as "CIS"), through its Principal Ms. Ritu Maddewad at having its At survey No 41(P), Latur- Nanded Highway, Talegaon village, Ahmedpur, Dist- Latur, (MS)

The Expressions "AIE" and "CIS" Shall mean and include their respective successions, legal representations and assignees.

1. PURPOSE

The purpose of this MOU is to foster collaboration between AIE & CIS. The aim is to establish a placement and academic link between the two institutions for mutual benefits and in a spirit of friendship and co-operation.

2. OBJECTIVES

The objectives of the MOU are-

- (a) To promote and enhances academic interest between AIE & CIS.
- (b) To provide placement opportunities at CIS for AIE students.
- (c) To promote research activities between the two institutions.
- (d) To promote student participation between the two institutions.

AIE and CIS are collaborating in order to provide placement opportunities to students enrolled at AIE.

Both parties hereto agree as follows:

1. Decisions regarding the placement of students (such as number of students, dates of placement, frequency of visit, duration, timings etc.) will be taken mutually.
2. CIS shall provide sufficient oversight of the program to ensure that it meets the needs of the students. AIE students will get exposure of working under the CIS school.
3. An orientation will be given to trainees by CIS before placement in classrooms.
4. During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by the CIS team (such as Taking classes, prepare necessary teaching learning material, provide group or individual attention to persons with special needs at CIS, volunteer in events and functions).
5. The minimum salary will be offer for mother teacher- 22,000 plus accommodation with food for PRT- 22,000 plus accommodation with food, for TGT- 25,000 plus accommodation with food and for PGT- 28,000 plus accommodation with food .
6. CIS will provide proper appointment letter and experience certification upon successful completion for their service tenure.
7. Army Institute of Education, Greater NOIDA will allow its students to attend the various events/ Seminar/ placement sessions conducted by CIS.
8. This agreement shall be effective for a period of three years from 15 February 2022 to 14 February 2025. Renewal of this agreement and continuation of the Program will be subject to each Party signing a renewal agreement.
9. There will be no financial liability on part of either party.
10. This agreement may be modified at any time by written consent of both Parties and may be terminated by either party at any time by giving at least thirty days' written notice.
11. The campus placement process will begin from 15th March of every consecutive year.
12. AIE shall provide the resumes of interested candidate before 1st January.
13. The interview process shall begin from 1st Jan and we shall provide the offer letter / appointment letter dated 15th feb to selected candidates and the actual date to join the institution would be before 1st March.
14. the academic session of our institution begins from 1st April every year.

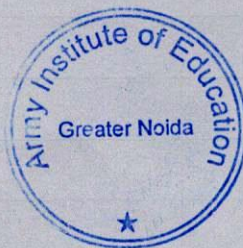

Dispute Resolution:

This is a non-binding Memorandum of Understanding ("MOU"). The parties recognize that a bona fide dispute as to certain matters may from time to time arise during the term of this MOU, which relates to either Party's rights or obligations hereunder. In the event of the occurrence of such dispute, either Party may, by written notice to other Party, have such dispute referred jointly to the authorized representatives of the Parties, or their successors or counterparts, for an amicable resolution by good faith negotiations within 15 days after such notice is received in respect of such dispute.
