MEMORANDUM OF UNDERSTANDING ON PLACEMENT AND CO-OPERATION

This MoU, based on general dissensions & Arguments, is executed on 20th December 2021.

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE"), through its principal Dr. Abhilasha Gautam at having its campus at M-1, Pocket P-5, Greater NOIDA, UP, INDIA.

AND

SHIVAM INTERNATIONAL SCHOOL, Rawla Mandi, SRI Ganganagar (hereinafter referred to as SIS), through its MD Mr. JP Mathiya having its head office at Rawla Mandi, Disst-SRI Ganganagar, Rajasthan 335707.

The Expressions "AIE" and "SIS" Shall mean and include their respective successions, legal representations and assignees.

PURPOSE

The purpose of this MoU is to foster collaboration between AIE & SIS. The aim is to establish a placement and academic link between the two institutions for mutual benefits and in a spirit of friendship and co-operation.

2. OBJECTIVES

The objectives of the MoU are-

- (a) To promote and enhances academic interest between SIS & AIE.
- (b) To provide placement opportunities at SIS for AIE students.
- (c) To promote research activities between the two institutions.
- (d) To promote student participation between the two institutions.

AIE and SIS are collaborating in order to provide placement opportunities to students enrolled at AIE.

Both parties hereto agree as follows:

- Decisions regarding the placement of students (such as number of students, dates of placement, frequency of visit, duration, timings etc.) will be taken mutually.
- SIS shall provide sufficient oversight of the program to ensure that it meets the needs of the students. AIE students will get exposure of working under the schools under SIS
- An orientation will be given to trainees by SIS before placement in classrooms.
- During their placement, AIE students will observe rules and regulations and execute responsibilities assigned by the SIS team (such as Taking classes, prepare necessary teaching learning material, provide group or individual attention to persons with special needs at SIS, volunteer in events and functions).
- The minimum salary will be offer for mother teacher- 20,000 plus accommodation, for PRT- 22,000 plus accommodation, for TGT- 25,000 plus accommodation and for PGT- 28,000 plus accommodation.
- SIS will provide proper appointment letter and experience certification upon successful completion for their service tenure.
- 7 Army Institute of Education, Greater NOIDA will allow its students to attend the various events/ Seminar/ placement sessions conducted by SIS.
- 8. This agreement shall be effective for a period of three years from 13 January 2021 to 12 January 2024. Renewal of this agreement and continuation of the Program will be subject to each Party signing a renewal agreement.
- 9. There will be no financial liability on part of either party.
- This agreement may be modified at any time by written consent of both Parties and may be terminated by either party at any time by giving at least thirty days PPS written notice.

Limitation of liability: Neither party shall be liable for any special, indirect, incidental, punitive, contingent nor consequential loss or damages suffered out of or in connection with the aforesaid MoU whether as a result of a breach of this MoU or otherwise.

Dispute Resolution:

This is a non-binding Memorandum of Understanding ("MoU"). The parties recognize that a bona fide dispute as to certain matters may from time to time arise during the

term of this MoU, which relates to either Party's rights or obligations hereunder. In the event of the occurrence of such dispute, either Party may, by written notice to other Party, have such dispute referred jointly to the authorized representatives of the Parties, or their successors or counterparts, for an amicable resolution by good faith negotiations within 15 days after such notice is received in respect of such dispute.
