Sub : Provisional Affiliation of Army Institute of Education for B.Ed. programme

Sir,

In terms of Section 5 (21) of the Indraprastha Vishwavidyalaya Act 1998, with the prior approval of Board of Affiliation, I am to convey the approval for provisional affiliation of **Army Institute of Education** for conduct of Bachelor of Education (B.Ed.) of one year duration with maximum permitted intake capacity of one hundred students for the academic session 2003-2004. The provisional affiliation is subject to the following conditions: -

- (i) That the society shall adhere to the provisions of the Act, the Statute, the Ordinances and regulations of the Indraprastha Vishwavidyalaya and will comply with the standing order & directions of the University & shall furnish an undertaking to this effect on the format enclosed as Annexure 'A'.
- (ii) That the institute shall be required to comply with the (a) General Standards for affiliation of new institutions/ programmes (Appendix-B), (b) General Standards in respect of quality parameters (Appendix - C) and (c) Specific Standards for affiliation of B.Ed. programmes as laid down by the University/ National Council for Teacher Education.
- (iii) That the admission for the session 2003-2004 shall be in conformity with the procedure as approved by the University & institute shall not announce admissions directly under any circumstances.
- (iv) That the course curriculum & fee structure will be as prescribed by the University/ State Govt.
- (v) That the institute shall be ready to pay the fee as prescribed below subject:
  - (a) Provisional Affiliation fee Rs. 3 lakh per course  
(intake- 100 students)
- (vi) That a governing body should immediately be formed as required under the University norms.



(vii)

faculty members are in position for the commencement of this course and a report to this effect duly verified by the Principal should be sent to the University within one month of commencement of the course.

(viii) That full scale and allowances shall be paid to Principal, faculty members, administrative staff and supporting staff as per the norms of UGC/University.

(ix) That the institute will not run any unaffiliated course in the same premises where University approved course is being conducted.

(x) That administrative and supporting staff shall be appointed as per the norms/standards of the University/NCTE before the commencement of the programme.

(xi) That the institution shall within one month of the receipt of affiliation letter strengthen the library with at least three thousand books as per the requirement of the B.Ed. course curriculum and report the University to this effect along with the list of titles, volumes, reference books, journals and magazines duly verified by the Principal.

(xii) To ensure a separate identity of the institute, the management committee should provide a separate budgetary allocation for this institute so as to promote it for planned growth for academic session 2003-2004.

2. The compliance report for aforesaid conditions be made available to the University within one month from the issuance of this letter.

3. In the event of infringement/ contravention or non-compliance of any of the conditions, guidelines, norms and regulations prescribed by the University from time to time, the University shall be free to withdraw affiliation & take further appropriate action, with out consideration of any related issues, and the liabilities arising out of such withdrawals would be solely that of the institute.
