Sub: <u>Continuation of provisional affiliation of Army Institute of Education for</u> B.Ed. Programme.

Sir/Madam,

- 1. In terms of Section 5 (21) of the Indraprastha Viswavidyalya Act 1998, with the prior approval of Board of Affiliation, I am to convey the approval for continuation of provisional affiliation of **Army Institute of Education** for conduct of Bachelor of Education (B.Ed.) of one year duration with maximum permitted intake capacity of 100 (One Hundred) students for the academic session 2004-05. The provisional affiliation is subject to the following conditions: -
 - (i) That the society shall adhere to the provisions of the Act, the Statute, the Ordinances and regulations of the Indraprastha Vishwavidyalaya Act 1998 and will comply with the standing orders & directions of the University.
 - (ii) That the admission for the session 2004-2005 shall be in conformity with the procedure as approved by the University and the institute shall not announce admissions directly under any circumstances.
 - (iii) That the course curriculum and fee structure will be as prescribed by the University/ State Govt.
 - (iv) That the Institute shall be ready to pay the fee as prescribed below:

Continuation of Provisional Affiliation Rs. 30,000/- (per course)

- (v) That the institute shall ensure the appointment of a permanent qualified and experienced Principal before the commencement of academic session 2004-05 and a report to this effect be submitted to the university at the earliest.
- (vi) That the institute will ensure that required faculty members duly qualified and staff as per the norms of the NCTE/ State Govt./ UGC is in position for the sanctioned intake before the commencement of the academic session 2004-05 and efforts should be made to recruit teachers who are able to teach core subjects as well as teaching subjects.

- That the institute will not run any unaffiliated course(s) in the same premises (vii) where University approved programme(s) is being conducted.
- That the institute shall keep augmenting the library with latest titles (at least 100 (viii) per year), required number of volumes, reference books and journals of national and international repute, magazines, newspapers relevant to the course curriculum in order to meet the requirement of sanctioned number of students.
- (ix) That the institute shall keep upgrading the configuration of terminals and provide Internet connectivity for working hours to make its students and teachers adequately conversant in the field.
- That the institute shall organize faculty development programmes and student (x) awareness programmes through seminars and workshops for continuing education focused on teacher education and innovative training.
- To ensure maintenance of educational values and quality, the management of (xi) the institute should make available a separate budgetary allowance in order to promote excellence and to emerge as an exemplary institution in its own orbit.
- The compliance report for aforesaid conditions and stipulations of National Council of Teachers Education/ Directorate of Higher Education, Govt. of NCT of Delhi be made available to the University within one month from the issuance of this letter.
- In the event of infringement/ contravention or non-compliance of any of the conditions, guidelines, norms and regulations prescribed by the University from time to time, the University shall be free to withdraw affiliation & take further appropriate action, with out consideration of any related issues, and the liabilities arising out of such withdrawals would be solely that of the institute
