MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COLLABORATION

This agreement is made on 20th April, 2024, between Army Institute of Education, herein after referred to as "AIE", which expression shall, unless exclude by or repugnant to the context, be deemed to include its successors in office and assignees) of the first part and Sanatan Dharma College, Ambala Cantt hereinafter referred to as "SDC" which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its/his/her/their respective executors, administrators and successors for the time being of the said College as the casamay be) on the second part.

WHEREAS Army Institute of Education was established in August 2003 with the aim of providing pre-service teacher education to the dependents of Army personnel under the aegis of

The Institute shifted to Greater NOIDA campus from Delhi Cantt on 23 July 2013 and is presently located in Plot M-1, Pocket P-5, Greater NOIDA, Gautam Budh Nagar (UP). The Institute is graded 'A' by NAAC in cycle 2 with CGPA 3.14, and is graded 'A', by Joint Assesment Committee (JAC), a high level inspection undertaken by GGSIP University, New Delhi.

And WHEREAS the Sanatan Dharma College, Ambala Cantt established in the year 1916, affiliated to Kurukshetra University, Kurukshetra, situated at Jagadhari Road, Ambala Cantt. Haryana is a premier multi-faculty post-graduate co-educational institution of Higher Studies delivering Education. Furthermore Sanatan Dharma College is NAAC Accredited institution that was awarded Grade "A++" with CGPA 3.72 in the fourth cycle. It has also been bestowed with the status of College with Potential for Excellence by UGC, New Delhi twice. College has also been chosenas DDU Kaushal Kendra by UGC, New Delhi. The College has a vision to build technology professionals with a practical Industry exposure to be readily deployable in the industry.

Whereas both the parties has shown their desire to enter into this agreement (MOU) that it could prove to be mutually beneficial to both the parties that allows for panoramic sharing of resource beyond the physical boundaries of College boundaries.

1. Objectives of MOU

The objectives of MOU are:

- a) To promote and enhance academic interest between SDC and AIE.
- b) To create means of cooperative efforts between the two institutes to effect academic collaboration through joint organization of Faculty development Programs, Workshops, Training Sessions and other academic activities for both students and teachers. It will also include Faculty & Student Exchange Programme along with other enrichment activities.
- c) To promote research work of teachers on aided or budgeted posts that can supervise/co-supervise joint research studies.

- d) Upgrading faculty with new teaching tools.
- e) Sharingof techniques and expertise for improving the quality of Education.

2. Technical areas of collaborations

- a) Provide academic interaction by delivering special lectures on topics of relevance to the inter-disciplinary research and literary studies at both institutes.
- b) Usage of research and academic infrastructure for students, staff and faculty members of both institutes.

3. Proposed mode of collaborations

SDC and AIE propose to collaborate through the following:

- a) Cooperation and promotion of research, education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between SDC and AIE. A specific plan will be worked out by the institutes depending upon availability of resources.

4. Terms and conditions

- a) The cost of development of infrastructure should be borne by the related institute.
- b) For education and research, the financial arrangements will be made on the basis of mutually agreed terms of both institutes.
- c) Usage of academic infrastructure of SDC and AIE can be allowed for limited period subject to its availability.
- d) Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.
- e) Each party will ensure appropriate protection of Intellectual Property Rights (IPR) generated from the cooperation pursuant to this MoU, consistent with their respective laws, rules and regulations and agreements to which both parties are committed.

Duration of MOU: The duration of this MOU shall be for a period of two years from the effective date.

Confidentiality: Each party agrees that it shall not, at any time, during or after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of
