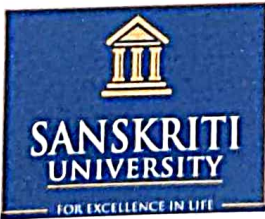

## MEMORANDUM OF UNDERSTANDING ON PLACEMENT AND CO-OPERATION

This MOU, based on general dissensions & Arguments, is executed on 08 April 2024.

BETWEEN

ARMY INSTITUTE OF EDUCATION (hereinafter referred as "AIE"), through its principal Dr. Abhilasha Gautam at having its campus at Plot M-1, Pocket P-5, Greater NOIDA, UP, INDIA.

AND

Sanskriti, University, Chhata, Mathura, (U.P) (hereinafter referred to as "SU"), through its Registrar Mr. Pooran Singh at having its campus at Sanskriti University, Chhata, Mathura, Uttar Pradesh 206245.

The Expressions "AIE" and "SU" Shall mean and include their respective successions, legal representations and assignees.

This Memorandum of Understanding (MoU) is made between the **Sanskriti University (SU)**, having its office at Chhata, Mathura, U.P., India (hereinafter called "SU") of the one part, and **Army Institute of Education, Greater Noida**, the other part.

WHEREAS the **SU**, has been established in the year 2016 after duly getting it notified under U.P. State Act. The University aims to bring "Excellence in Life" to the students by providing value-based education in Agriculture, Arts, Commerce, Education, Engineering, Fashion Designing, Indian Medicine, Law, Para-medical, Management, Rehabilitation, Science, Tourism & Hospitality. The **School of Education** of SU has the key objectives to impart skill-based education in different programmes of education, undertake, aid, promote and coordinate teacher education and research and its application in practice; to act as a clearing house of information, in regard to educational research and related matters generally and to do all other things as it may consider necessary, incidental and conducive to the attainment of these objectives, and promote linkages with national and international educational institutes.

AND WHEREAS The Army Institute of Education (AIE) is NAAC 'A' graded institution with CGPA 3.14, and is graded 'A' by Joint Assessment Committee (JAC), a high-level inspection undertaken by GGSIP University, New Delhi. It was established in 2003 to provide pre-service teacher education to the dependents of Army personnel under the aegis of the Army Welfare Education Society (AWES), Delhi. It is running B.Ed programme and B.Ed Special Education (Learning Disability) programme. AIE provides an ideal environment for aspiring learners to pursue their studies in education. It cradles a genuine concern for the pursuit of human enquiry and the perpetuation of knowledge traditions in an environment conducive to an inspiring teacher education programme.

NOW THEREFORE, SU and AIE inspired by the common objectives to promote and accelerate the progress of research, placement and internship programmes;

HAVE decided to enter into this MoU to promote cooperation in the field of education and research through:

## **Article I – Objectives**

- 1. The parties here by agree to promote cooperation in the field through:**
  - (a) Organize professional development programs
  - (b) Exchange of educational information and methodology
  - (c) Development and implementation of collaborative research projects, the areas and methodology to be as mutually agreed upon.
  - (d) Placement of pupil teachers.
  - (e) Skill development through internship programmes.
  - (f) Faculty & Student Exchange Programme along with other enrichment activities.
  
- 2. Such cooperation shall be implemented by the following means:**
  - (a) Establishment of mutual relation between the scientific and technical divisions of the organizations of the respective parties
  - (b) Creation of facilities for internship of pupil teachers and their placement.

## **Article II- Implementation**

The SU and AIE may name any member of their staff to work out the details of cooperation between the two institutions and in general to ensure proper and effective implementation of this MoU.

## **Article III - Work Plans**

This MoU will be implemented through biennial Work Plans to be developed jointly, which describe specifically the activities to be carried out under this Cooperation and which set forth the intended contributions of each party. These Work Plans may originate from either party but will require the full approval of both parties for implementation.

- 5. Article IV- Publication & Intellectual Property Rights General Clauses**
  - (a) Each party will ensure appropriate protection of Intellectual Property Rights ("IPR") generated from the cooperation pursuant to this MoU, consistent with their respective laws, rules and regulations and international agreements to which both parties are committed.
  - (b) In case research is carried out solely and separately by one party or the research results are obtained through the sole and separate effort of one party, the IPR will be solely owned by the concerned party.
  - (c) In case of research results obtained through joint activities, these rights will be jointly owned by both the parties.
  - (d) The parties shall not assign any rights and obligations arising out of the joint IPR generated to inventions/ activities carried out under the MoU to any third party without the consent of the other party.



### **Commercialization**

(e) In case of research results obtained through joint activities under this MoU, both the SU and the AIE will apply as co-applicants for the protection of intellectual property rights subject to exclusive rights of both the parties to commercialize the technology in their respective regions. Commercialization in any other region shall be done jointly through a separate agreement.

### **Publication**

(f) Any publication, document and/ or paper arising out of joint work conducted by the parties pursuant of this MoU will be jointly owned. The use of the name, logo and/ or official emblem of the parties on any publication, document and/or paper will require prior permission of both parties. It may however be sure that the official emblem and logo is not misused.

### **Confidential Information**

(g) All information and documents to be exchanged pursuant to this Memorandum of Understanding will be kept confidential by the parties and will be used to subject to such terms as each party may specify. A party will not use the information for purposes other than that specified without the prior written consent of the other party.

(h) All confidential Information shall remain the exclusive property of the disclosing party. The parties agree that the disclosure of the Confidential Information do not grant or imply any license, interest or right to the Recipient in respect to any intellectual property right of the other Party.

(i) Unpublished information, whether oral, in writing or otherwise, discovered or conceived by the staff, students and technicians and exchanged under the provisions of this MoU will not be transmitted to a third party, unless otherwise agreed by both parties.

## **6. Article V- Disclosure of Information:**

(a) The SU and AIE agree that except for a Court Order requiring disclosure, neither shall disclose to any third party without the written consent of the other, any information made available to the parties, in the performance of work and/or generated by the performance of work, under this agreement, except information which at the date hereof was:

(i) In the public domain

(ii) Known to either prior to the date hereof as evidenced by written documents subsequently.

(iii) All data generated through this Memorandum of Understanding with assistance by the SU or AIE work programme shall be subject to explicit written approval signed by school before publication of same by the SU and/or the collaborating institute.

(iv) All data generated through this Memorandum of Understanding with assistance by AIE from the SU's work programme of a collaborating institute in India shall be subject to explicit written approval signed by the SU or AIE.

The provisions of this Article shall continue for **Five years** after the termination or completion of the Memorandum of Understanding.

#### **Article VI- Amendments**

The parties to this MoU may, by mutual written consent, add, modify, amend or delete any words, phrases, sentences or Articles in this MoU.

#### **Article VII- Institutional Links**

Both parties will establish inter-institutional links between their respective similar educational institutes and centers.

#### **Article VIII- Joint Working Group**

A Joint Working Group will be set up with representatives from both parties to meet once in two years alternately in SU and AIE to follow up the execution of this MoU and suggest necessary measures for its development.

#### **Article IX- Financial Arrangements**

In the case of exchange of staff and students for study visits on the basis of reciprocity, for training and consultancy, financial agreement shall be decided by mutual consent of both parties.

#### **Article X- Dispute Settlement**

In case of any dispute in relation to academic cooperation, Authorized Signatory, SU and Authorized Signatory, AIE will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility. Even then, if any issue still remains unresolved, then it shall be referred to the Arbitrator who shall be appointed with the consent of the both institutions. The seat of the Arbitrator shall be at **Mathura or Samastipur** and proceedings shall be in accordance with the provisions of the Arbitration and Conciliation Act, 1996.

#### **Article XI- Validity/ Termination**

This MoU shall be effective from the date of its signing by both parties. It shall be valid for a period of **Three years**. Thereafter it may be renewed for a period of next two years with mutual consent of both parties. Either Party may serve notice on the other of its intention to terminate it, in which event, the Memorandum of Understanding shall stand terminated at the end of one calendar month from the date of issue of such a notice. The termination of this Memorandum of Understanding shall not affect the validity or duration of specific collaborative programmes already being undertaken there under, unless decided otherwise by the Parties by mutual consent.
