- 1. A Discipline committee meeting was held on 19th July 2023. The meeting was chaired by Dr Abhilasha Gautam, Principal of AIE and Col Abhay Rajvanshi, Registrar & HOA of AIE. Ms. Kusum Warden Girls Hostel, Ms Jyotsna (Asst prof), Ms. Megha Kumari HR of batch 2021-23, Virnda Rawat and Snehashree Nayak (students of batch 2021-23) were present in the member meeting. The meeting commenced at 12:20 pm by 1:30 pm.

| 1. | Violation of Discipline in Hostel | Dr. Abhilasha Gautam, Principal of AIE initiated the meeting and asked Vrinda Rawat and Snehashree Nayak to explain what happened on the night of July 16, 2023. |
| | | Snehashree Nayak mentioned that she was listening to music from her laptop without earphones in her hostel room. Vrinda Rawat was also present in the room. Snehashree Nayak stated that Vrinda Rawat rudely asked her to turn off the volume, and after doing so, Vrinda Rawat demanded again to turn it off. When Snehashree Nayak refused, Vrinda Rawat snatched the laptop and threw it on her bed. A physical altercation followed when Snehashree Nayak pushed Vrinda Rawat in self-defense, and then Snehashree Nayak held Vrinda Rawat's hand tightly. |
| | | Vrinda Rawat denied Snehashree's version of the events and claimed that Snehashree Nayak was listening to music at |



a high volume, even with earbuds. She asked Snehashree Nayak to turn it down, and when she touched Snehashree's laptop, Snehashree Nayak pushed and slapped her, leading to a fight. Vrinda Rawat showed marks on her body as evidence.

Vrinda Rawat brought up a previous argument in the cafeteria where she asked Snehashree Nayak for the room key, which Snehashree Nayak refused to provide. This led to a heated confrontation in the presence of other batchmates.

Snehashree Nayak stated that she had not been staying in her room since the cafeteria incident but returned because her friend left the hostel. She admitted to not informing the authorities about her absence.

Col Abhay Rajvanshi, Registrar & HOA of AIE asked both students why they did not inform any faculty or the warden about their issues.

Dr. Abhilasha Gautam, Principal of AIE questioned both Vrinda
Rawat and Snehashree Nayak if they felt any satisfaction
or enjoyment in resorting to violence. Both students
denied any such feelings.

Dr. Abhilasha Gautam, Principal of AIE asked them to reconsider their actions and think about how they could have handled the situation differently to avoid violence.

Snehashree Nayak acknowledged that she could have stopped talking to Vrinda Rawat or left the place to avoid confrontation.

Vrinda Rawat admitted that she should not have responded to

violence with violence

Both Vrinda Rawat and Snehashree Nayak agreed to resolve the issue within the college. Both Vrinda Rawat and Snehashree Nayak apologized to each other for their actions and wrote apology letters, which they exchanged.

The meeting was adjourned with an understanding that the hostel authorities would monitor their behavior and any further issues should be reported to them for resolution

DECISION MADE BY COMMITTEE

The committee resolved that Vrinda Rawat and Snehashree Nayak are required to draft letters of apology, acknowledging their errors, and commit to refraining from any such misconduct. Failure to adhere to these conditions will result in the committee taking rigorous actions against both individuals.
