## REPORT ON VIGILANCE AWARENESS WEEK : 28 OCT - 03 NOV 2024

In pursuance of the directions of the Central Vigilance Commission, the Army Institute of Education, Greater Noida, observed the Vigilance Awareness Commission (CVC) from 28<sup>th</sup> October to 3<sup>rd</sup> November 2024 on the theme, 'Culture of Integrity for Nation's Prosperity'.

The observance of the Vigilance week commenced with taking of the integrity pledge on 28<sup>th</sup> October 2024 at 11.00 hours with the employees assembling in the conference hall and taking the pledge. The Principal, Dr Abhilasha Gautam stressed upon the importance of honesty in personal and professional lives and reminded everyone of the ethical conduct that should form the foundation of all endeavours. Further to that, the student community took the e-integrity pledge to promote and uphold ethical behaviour and to maintain integrity, honesty and transparency in all walks of life. 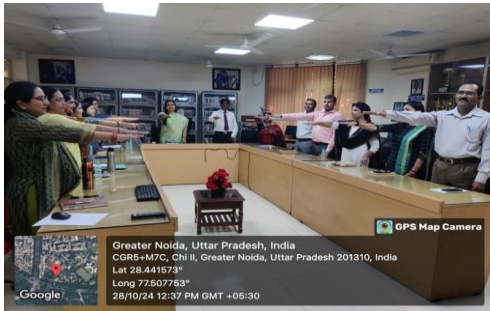
### Learning Outcome
